SHARES AND VOTING RIGHTS

EXTRAORDINARY GENERAL MEETING

to be held on Thursday 17 November 2016 at 11:30 a.m.

This overview has been prepared by Nyrstar NV in accordance with article 533bis, §2, b) of the Belgian Companies Code.

On 28 October 2016, the Company has 93,563,960 outstanding ordinary shares. (1) Each share gives the right to one vote.

Note:

(1) Pursuant to a decision of the Board of Directors of 11 September 2013, the Company issued 4.25% senior unsecured convertible bonds due 2018 for an aggregate principal amount of EUR 120,000,000 (the "2018 Bonds"). The possibility to convert the 2018 Bonds into new shares of the Company was approved by the extraordinary general shareholders' meeting of the Company held on 23 December 2013. The 2018 Bonds can be converted at any time. To date, no 2018 Bonds have been converted. The conversion price of the 2018 Bonds can be adjusted downwards in a number of circumstances, including in the event of certain distributions on the outstanding shares. The current conversion price of the 2018 Bonds is EUR 21.63 per share. Based on a conversion price of EUR 21.63, if all 2018 Bonds were converted in their entirety, 5.547.850 new shares would be issued.
